FROM THE EAST:

Take I-74 west toward Danville
Take exit 215A (Route 1) to Westville (5 miles)
At Westville, turn left (east) at Main Street
Follow asphalt road (Co. Hwy. 5) for 7 miles
Park entrance on the left

FROM THE SOUTH:

Take Route 1 north to Georgetown
Turn right (east) 2 blocks from Mill St. look for brown sign
Follow Mill St. for 2.5 mi., turn left (north) watch for brown sign
Go 1 mile to T-road and turn right (east)
Park entrance on left after 1 mile

FROM THE NORTH:

Take I-57 south to Champaign
Take I-74 east to Danville
Take exit 215A (Route 1) to Westville (5 miles)
At Westville, turn left (east) at Main Street
Follow asphalt road (Co. Hwy. 5) for 7 miles
Park entrance on the left

FROM THE WEST:

Take I-74 east toward Danville
Take exit 215A (Route 1) to Westville (5 miles)
At Westville, turn left (east) at Main Street
Follow asphalt road (Co. Hwy. 5) for 7 miles

Take Route 1 north to Georgetown
Turn right (east) 2 blocks from Mill St. look for brown sign
Follow Mill St. for 2.5 mi., turn left (north) watch for brown sign
Go 1 mile to T-road and turn right (east)
Park entrance on left after 1 mile

FROM THE NORTH:

Take I-57 south to Champaign
Take I-74 east to Danville
Take exit 215A (Route 1) to Westville (5 miles)
At Westville, turn left (east) at Main Street
Follow asphalt road (Co. Hwy. 5) for 7 miles
Park entrance on the left

FROM THE WEST:
